### **History of Supervisor**

I obtained a Master's degree in school counseling over fifteen years ago and have worked in a public high school since graduation. Currently, I am completing a Ph.D in Counselor Education and Supervision at Liberty University. During my work in the high school, my counseling style is person-centered, and my theory of choice is Solution-Focused Based Therapy. This type of therapy emphasizes solutions, and client strengths which are both strong and necessary tenets.

### Supervisory Model & Style

With regards to Supervision, I prefer a collaborative approach with an amicable tone. It is important to be mindful that we want the same goals – improvement of counseling skills. At times, the feedback may be difficult to hear; please remember that your effectiveness is of critical importance. I firmly make every effort to live out the mantra "speaking the truth in love".

The model that aligns most closely with my natural helping style is the Developmental Model. As the name implies, this model expects the supervisee to begin at a fairly basic level of implementing counseling techniques and progress to complex interactions. This model does not follow a standardized uniform approach to supervision, but rather allows for flexibility along the journey of improvement for the Master's Counselor. There are eight areas of focus within three stages (Stagnation, Confusion and Integration). In counseling, it is extremely helpful to realize that learning and improving is never-ending. The effective counselor is always seeking feedback, and researching new information.

#### **Frequency of Supervision**

We will meet once a week for an hour. To maximize effectiveness of our session, in our first session I will provide a general outline of what we need to accomplish throughout the duration of the supervision. We can decide together on the timeline of our goals, and each week you will be expected to complete the assigned task and be prepared for discussion the following week.

- Should the need for termination occurs, I will make a proper referral to possible supervisors
- Provide Evaluation (formative and summative)
- Gatekeeping and Remediation

#### **Supervisee Responsibilities**

These responsibilities include but are not limited to:

- Attend supervisory sessions
- Complete assignments given
- Maintain an open posture to accepting feedback
- Communicate honestly with the supervisor in a respectful tone even indicating if there is a disconnection between both of you.

## Rights of supervisee

The supervisee deserves to receive a face-to face 1 hour session each week during this supervisory experience. At any time that the supervisory relationship becomes problematic in any way or uncomfortable, please feel free to address these concerns quickly, so that progress is not hindered.

### **Record Keeping**

A signed copy of our contract will be based on your file. Also, I will keep all videos and notes that are made throughout the time allotted. We will review your notes together and at the end of the sessions, you are entitled to copies of all of your information.
